ASSESSMENT CRITERIA

Council has set out the objective and decision guidelines that the municipal building surveyor will exercise when considering varying a design and siting standard for fencing.

Note: If any matter set out in the guideline is not met, then Council **must refuse** consent.

Objective: To ensure that the location, length and height of a fence on a street alignment does not obstruct the vision of road users and is consistent with the neighbourhood character.

Decision Guidelines: The reporting authority may give its consent where a fence does not comply with regulation 427 of the Building Regulations 2006 (as ratified by Council), if -

(a) the location, length and or height of the fence will be appropriate taking into account the obstruct of vision of road users; or

(b) the slope of the allotment reduces the effective height of the fence; or
