### Hello councillors & CEO of the Hindmarsh Shire Council,

I wish to bring your attention to correspondence that was sent to the previous cohort of councillors at the end of their service time, and as such you may not be aware of this important issue.

On 11<sup>th</sup> October 2024, Port Hedland council voted on a motion to ask for the immediate suspension of Moderna and Pfizer modRNA Covid vaccine. This request was sent to all councillors in Australia and the Australian Prime Minister, Mr Anthony Albanese.

Since that meeting 2 other councils in Australia, District Council of Ceduna and West Tamar Council have also moved motions to support the Honourable Russell Broadbent MP in calling for the suspension of the Pfizer and Moderna Covid shots and demanding answers from the Prime Minister.

The study that is backing up Mr Broadbent's request found that vials of Covid vaccines were tested by the industry standard methods and the results have revealed that there is DNA contamination in the vaccines – of up to 145 times above the legal limit.

Although the TGA has released a media statement that this claim is false, there is evidence that the TGA's statement is misleading, as the standard testing on these vaccines was not done by the TGA.

Dear Australian Mayors, Deputy Mayors, and Councillors

Port Hedland Council Motion to immediately suspend Moderna and Pfizer modRNA Covid vaccines pending a thorough investigation into the evidence of excessive levels of synthetic DNA contamination

My name is Camilo Blanco, and I write to you as a proud native of the Town of Port Hedland, where I was raised since the age of 4, and established my family. As a successful automotive repairs business owner, a currently serving Councillor, and the former Mayor of our great town, I care deeply about the well-being of Australians. I wish to bring to your attention a matter of urgent importance.

On 11 October 2024, the Town of Port Hedland Council held a <u>Special Meeting</u> during which we passed a motion to inform all Local Government Councils and Shires in Australia of the significant findings contained in the DNA contamination <u>report by the Canadian molecular virologist Dr. David Speicher</u>, who analysed Australian vials of the Pfizer and Moderna Covid vaccines. The motion was passed to ensure that all Councils and Shires receive this information as promptly as possible so that they may give it due consideration.

The motion also called for the immediate suspension of the Pfizer and Moderna COVID-19 vaccines pending a thorough investigation into Dr. Speicher's alarming discovery of excessive levels of synthetic DNA contamination in these products.

These findings have been shared with the Prime Minister by the Honorable Russell Broadbent MP in his <u>letters dated 20 and 25 September 2024</u>. They have profound ramifications for the health and safety of all Australians, as was explained to Port Hedland Council in <u>video</u> <u>testimony</u> from renowned British oncologist Professor Angus Dalgleish, which was both confronting and compelling.

I am taking this step to inform you directly as, by an unfortunate oversight, Order 2(C) of our Motion only requires the following generic form of letter (below) to be delivered to all Australian Local Government Councils and Shire Administrations.

In my private capacity I formed the view that *all Councillors* across our nation deserve to receive this material and have the opportunity to review it thoroughly, before your Administrations receive the same, given its potential implications.

I do not need to tell you about the duty of care we each carry on our shoulders re the health and safety of our constituents. Waiting for the bureaucratic process to run its course and thereby allowing our fellow Australians to potentially be subjected to more harm, is not something that sits lightly on my conscience.

Recent <u>denials</u> from the Therapeutic Goods Administration (TGA) regarding the findings of synthetic DNA contamination in the Pfizer and Moderna vaccines have been met with widespread condemnation, ridicule and anger from many of the world's leading scientists. Details in the Science Summary shared by Russell Broadbent MP with the Prime Minister in his <u>letter</u> of 25 September 2024 remain unchallenged.

The TGA's reliance on outdated testing methodologies and its refusal to be transparent and share evidence it claims supports their claims does nothing to allay concerns about the significant risks these products potentially pose, including genomic integration and heightened cancer risk. There has never been a more urgent need for updated testing, and transparency in the scientific method, to confirm or disprove the new revelations of DNA contamination, to ensure the safety of all Australians.

I trust that you and your fellow Elected Members will examine this information as extensively and as thoroughly as did our own Council at the Town of Port Hedland, and act by Notice of Motion or Special Council meeting to consider the findings of Dr Speicher and request of the Prime Minister the same as we have – an immediate suspension of the products and a thorough investigation.

## Re: Urgent Information Regarding DNA Contamination in COVID-19 Vaccines

I write on behalf of the Town of Port Hedland Council to bring to your immediate attention <u>a report</u> by Dr. David Speicher PhD, which presents disturbing findings of synthetic DNA contamination in Pfizer and Moderna COVID-19 vaccines.

Dr. Speicher's testing revealed that the contamination levels in these vaccines exceed Australia's Therapeutic Goods Administration (TGA) safety limit by up to 145 times. Furthermore, the Pfizer vaccines contain SV40 promoter-sequences, which are well known for facilitating genomic integration and amplifying cancer risk.

The Town of Port Hedland acknowledges <u>the letters</u> from the Honorable Russell Broadbent MP, dated 20 September and 25 September 2024, which were co-signed by over fifty of the world's leading Doctors, Professors, Scientists and Legal Experts from Europe, North America and Australia. We extend our gratitude to Mr. Broadbent for raising awareness of Dr. Speicher's critical findings.

Moreover, after reviewing the Science Summary attached to Mr. Broadbent's <u>letter</u> dated 25 September 2024, we are gravely concerned about the potential health risks posed by synthetic DNA contamination, including the dangers of genomic integration, cancer, hereditary defects and immune system disruption. The Town of Port Hedland therefore joins Mr. Broadbent in calling for the immediate suspension of Pfizer and Moderna COVID-19 vaccines, and for an urgent investigation into how this contamination has gone undetected by our regulatory agencies.

We have also taken steps to inform all Australian Local Government Councils of Dr. Speicher's findings, and have communicated with health practitioners in the Port Hedland area to ensure that patients are provided with the necessary information to warrant legally valid informed consent.

In the attached letter to the Prime Minister, we have highlighted serious concerns regarding the apparent failures of the Therapeutic Goods Administration (TGA) in properly or adequately testing for synthetic DNA contamination in the Pfizer and Moderna vaccines. Despite having been clearly alerted to the inadequacy of certain testing methods and the risks posed to human health by this drug platform, the TGA has relied on insufficient methodologies. We urge you to carefully review these findings, as they reveal grave risks and shortcomings that could have a significant impact on the safety of all Australians.

We strongly encourage you to share this information with your local health practitioners and medical clinics.

We reiterate the urgent need for action to ensure the safety of all Australians. We respectfully request that your Council also seek urgent answers from the Prime Minister and join us in calling for the immediate suspension of these products and a thorough investigation into the contamination.

Follow-Up on DNA Contamination Findings Re TGA statement, misleading

## Introduction

Further to my 23 October email to you (resent 1 November), I write to you again in my private capacity to share significant updates on the synthetic DNA contamination found in Pfizer and Moderna's COVID-19 vaccines.

I have been very heartened by the supportive responses from many of you across Australia, who recognise the urgent need to protect public health at the local level in the face of concerning revelations.

As you will recall, our Council passed a Motion supporting the call from Russell Broadbent MP for an immediate suspension of the COVID-19 vaccines, pending a thorough investigation into the confirmed **DNA contamination**, which presents risks of genomic integration, cancer, and other severe health impacts.

## Town of Port Hedland's Letter now sent to all councils

I have learned that in the last week, the Town of Port Hedland's outgoing CEO has now sent the communications to all councils within Australia in accordance with the 11 October 2024 Special Motion. If you have not received a copy of the email formerly, I encourage you to contact your administration.

While I have still not been supplied a copy of what was sent by our CEO, I understand that this communication includes a unilateral addition not approved by the Town of Port Hedland Council Members regarding the Therapeutic Goods Administration (TGA).

The purpose of this further email from me is to give you an update and to provide further information on the TGA's statement being inaccurate and misleading.

## Addressing TGA's Allegations - Russell Broadbent MP's third letter to the Prime Minister

Since writing to you last, I wish to bring to your attention a **<u>further letter</u>** from Russell Broadbent MP to the Prime Minister. This letter is dated 29 October 2024 and exposes the numerous inaccuracies and misleading statements in the TGA's 18 October 2024 **statement** that seeks to downplay these contamination findings. This is Mr Broadbent MP's third letter to the Prime Minister on this significant problem.

That letter, supported by the expert article <u>Addressing Allegations that DNA Contamination in</u> mRNA Shots is 'Misinformation', was authored by investigative journalist Rebekah Barnett and a cohort of prominent scientists and researchers, provides clear evidence that the TGA's claims lack any scientific credibility.

Key points raised in the article Addressing Allegations include the TGA's use of wholly inappropriate testing methodologies and avoidance of rigorous DNA contamination tests, as detailed in Moderna's patents and confirmed in independent laboratories worldwide.

The TGA's testing method (qPCR) under-measures synthetic DNA levels by as much as 100 times or more, which Moderna earlier alerted the TGA about, but which the TGA ignored, which raises serious questions about the agency's commitment to public safety. Mr Broadbent has addressed these concerns in his 29 October letter to the Prime Minister.

The TGA's statement also fails to address recent scientific findings regarding synthetic DNA, particularly its potential to integrate into human genomes.

Critically, the TGA has not conducted or referenced any independent genotoxicity tests specific to these mRNA vaccines. The <u>Science Summary – Consequences of Synthetic DNA</u> **contamination**, attached to Mr Broadbent's **letter of 25 September 2024**, outlines grave risks associated with synthetic DNA encapsulated in lipid nanoparticles, including genomic integration risks and potential cancer triggers. The absence of such studies fundamentally undermines the TGA's reassurances of product safety.

However, we can inform Councillors studies are now emerging evidencing genomic integration with natural human DNA.


In the Addressing Allegations article (section 12) it states:

"It is significant that the TGA denied the existence of evidence that mod-RNA vaccines in Australia are resulting in integration of residual DNA into the human DNA genome because there is early evidence of integration in tests outside of Australia.

As I reported in March of this year, McKernan has detected vaccine contaminant DNA in ovarian cancer cell lines treated with Pfizer's Covid vaccine in an experiment conducted together with German molecular biologist Dr Ulrike Kämmerer. 9"

The scientists found a chimeric combination of human ovarian cell line DNA and spike sequence DNA derived from the contaminating plasmid at at least one, and possibly two sites, which is suggestive of DNA integration.

If anything, this work has put to bed the question regarding if this contaminant DNA gets into the cell, and the chimeric human and contaminant spike DNA sequences imply it has entered the nucleus," McKernan said at the time.



Just this month, McKernan <u>posted early results of further testing</u>, which appear to similarly show integration events; however, this work is not yet written up in full, so it will not be discussed further here."

It should be further noted by Councillors that these integration events studied by McKernan also found evidence that Pfizer's synthetic DNA contamination appeared to be self-replicating within the cancer tumor of the patient. The patient has since deceased.

Next steps and support

As mentioned, I have received hundreds of messages of support from other councillors across Australia, many of whom are taking steps to replicate our efforts here in Port Hedland to ensure that all residents are informed and protected.

This collaborative approach, in which Councils are notifying health practitioners of **Dr. Speicher's** <u>findings</u> and seeking transparency from both Commonwealth and State authorities will surely prompt the Federal Government into taking long overdue action.

To assist, a new resource website, **Port Hedland Motion Info**, has been launched by concerned citizens to assist Australians in connecting with their local councils to voice support for the actions initiated by the Town of Port Hedland Council on 11 October.

prioritize your duty to protect public health. Replicating the motion materials and exhibits created by Port Hedland makes the task easy. We cannot ignore the mounting evidence that significant contamination risks may be affecting millions of

Australians, as detailed in the testimony of renowned UK oncologist, Professor Angus Dalgleish.

I urge you, as community leaders, to continue pursuing answers and consider adopting motions that

Professor Dalgleish is not alone. Recently a UK colleague Dr James Royle who is a consultant surgeon, provided testimony before a Covid inquiry during which he stated:

"Post-vaccine boosters, I've observed what seem to be a lot of sudden deaths from necrotising pancreatitis,"

"Cancers being observed are in all ages. It is my assertion, shared by many expert oncologists and clinical colleagues around the world, that the cancers we are seeing are extremely aggressive and they are of a different biology,"

Dr Royle continued:

"These cancers have been termed colloquially 'turbo cancers'.

"Obviously this is not a scientific term but it seems to reflect the aggressive biological nature being observed by the public as well as clinicians."

Clearly this critical issue cannot be left solely to federal authorities who have yet to provide satisfactory evidence to allay public concern.

#### Dear Representative

I write on behalf of the Australian Medical Professionals Society (AMPS), a peak body representing doctors in Australia, to inform you of critical developments regarding synthetic DNA contamination found in the Pfizer and Moderna COVID-19 vaccines administered to Australians. These developments call for urgent attention, particularly from Australia's local councils, which have a duty of care to the health and safety of their residents.

AMPS has confirmed that all major Australian medical and science colleges and associations have been made aware of the synthetic DNA contamination findings from Dr David Speicher and other renowned scientists. Excessive levels of synthetic DNA contamination are found in these vaccines. However, these organisations have remained unresponsive, likely influenced by the Therapeutic Goods Administration's (TGA) recent misleading and incorrect statement, released on 18 October 2024, which erroneously claims to refute independent evidence against the scientific exposure of the contamination.

This TGA statement has since been shown to be scientifically unsound, reflecting a failure to detect or address the contaminant properly, potentially affecting millions of Australians. See the co-authored article addressing allegations that DNA contamination in the mRNA injections is "misinformation."

Accompanying this is a <u>letter dated 29 October 2024 from MP Russell Broadbent to the Prime Minister</u>, addressing the TGA's misleading claims.

A thorough legal analysis of the Local Government Act legislation governing councils across all states and territories indicates that the responsibility for mitigating the risks of this contamination now also falls within your jurisdiction.

Moreover, it is crucial to recognise the extensive censorship that has permeated discussions on COVID-19 and related health issues. This censorship has been evident across medical media, social media, and through medical regulators who have threatened health professionals with disciplinary action for expressing alternative opinions to those endorsed by the government, health bureaucracies and the pharmaceutical industry. Such actions have resulted in a substantial loss of confidence in public institutions, a concern acutely highlighted in the recent report from Prime Minister Albanese's government's "Independent Inquiry into COVID."

Reliance on an authority is valid only when that authority is reliable. The TGA's assertion that the contamination findings are "misinformation" has since been disproved, as documented in the detailed response from notable experts, including Prof. Robyn Cosford and Dr. David Speicher, published on 27 October 2024. Given the TGA's lack of credibility on this issue, councils and shires now need to carefully evaluate their Duty of Care to residents in light of this contamination.

#### The Duty of Care of Councils

AMPS strongly recommends councils exercise due diligence by thoroughly reviewing the evidence presented by <u>Russell Broadbent MP to the Prime Minister</u>. Relying solely on the TGA in this matter may no longer serve as a shield against legal action. The TGA's failure has increased your responsibility to actively protect your residents' health. This being the case, we urge councils to:

- Examine Evidence Independently: Consider the scientifically substantiated concerns raised by experts, including the testimony from <u>Professor Angus Dalgleish</u> presented to the Town of Port Hedland Special Meeting, and assess the effect of potential contaminants on community health in your district.
- 2. Address the Emerging Health Crisis: This contamination issue already appears to be contributing to an increased disease burden, as indicated by international research into rising cancer numbers. Port Hedland's recent motion demonstrates one way how local governments can proactively address these serious concerns.
- 3. Call for Suspensions and Investigations: Align with the precautionary stance advised by MP Russell Broadbent and Senator Malcolm Roberts, who have called for an immediate suspension of the Pfizer and Moderna products until a full investigation can be conducted. Suspension poses no health threat but could prevent further harm if the contaminants in these products are shown to be widespread, thereby endangering public health.


The Town of Port Hedland's historic motion on 11 October to alert councils across Australia exemplifies the way local governance can protect residents where federal agencies have faltered. Port Hedland Council's actions set a model for active address of these severe and emerging health risks.

Regardless of any wider beliefs beyond the validity of the COVID injections or about COVID itself or about vaccination in general, we point out that by any measure the behaviour of this country's medical system has been reckless and blameworthy. In our published seminar proceedings *Covid Revisited* we note:

- The government's policy response to COVID-19 appears to have been made using poor-quality pharmaceutical-company-sponsored data passed off as evidence;
- The modelling of COVID-19 the disease was pessimistic and inaccurate;
- The modelling of the benefits of the COVID-19 vaccines has been equally inaccurate, but wildly over-optimistic;
- Testing methods have been inaccurate;
- There has been misinformation on safety and efficacy of provisionally-approved vaccines;
- Cheap, repurposed, fully-approved and promising COVID-19 early-treatment medicines were
  denied the public and suppressed in favour of highly-expensive, provisionally-approved drugs
  such as paxlovid, molnupiravir and gene-based vaccines;
- Data collection has been very poor;
- Pharmacovigilance has been of an extremely low standard;
- Throughout there was no decision-making transparency.

To see the extent of this Australia-wide calamity in a visual form may help at this point:

Now, there are people in your council area who are suffering grievous harm from the effects of these injections. We commend Port Hedland's leadership and we point out that you as an individual councillor have a role in prioritising this health issue for the safety of every Australian family in your local government area. Protecting the health of your residents is both a legal duty, and an ethical imperative.

## Accordingly, we ask you:

- 1. What are you as a councillor in the local area doing to rectify the lack of public knowledge about the vaccine harms?
- 2. What are you as a councillor doing to publicise the class action (see <u>Covid Revisited</u>, accompanying, and <u>https://www.covidvaxclassaction.com.au/join/</u>)?
- 3. Given the role taken by local government functionaries in public health initiatives, complying with state and territory public health legislation, and playing a role in work health and safety involving risk assessment, is it not your personal duty to bring these scientific developments to the attention of your electors?
